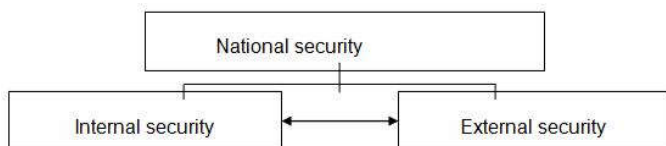


Figure 1.1 . General outline of national security
